

**Chung Yuan Christian University (CYCU)**  
**Hourly Pay of Large-Scale Classes, Lectures Classes, and Summer School**  
**Regulations**

Article 1 Article The following system is the hourly pay of regular Large-Scale classes regulations, taking the form of 11 classes are as follows:

Classes	Number of students	Benefit Payment Standards
The First Class	Less than or equal to 85 people	Minimum Hourly Pay
The Second Class	86~100 people	Additional 10%
The Third Class	101~115 people	Additional 15%
The Fourth Class	116~130 people	Additional 20%
The Fifth Class	131~145 people	Additional 25%
The Sixth Class	146~175 people	Additional 30%
The Seventh Class	175~200 people	Additional 35%
The Eighth Class	More than or equal to 201 people	Additional 40%

Article 2 The following system is the hourly pay of lectures Large-Scale classes regulations, taking the form of 8 classes are as follows:

Classes	Number of students	Benefit Payment Standards
The First Class	Less than or equal to 85 people	Minimum Hourly Pay
The Second Class	86~100 people	Additional 10%
The Third Class	101~115 people	Additional 15%
The Fourth Class	116~130 people	Additional 20%
The Fifth Class	131~145 people	Additional 25%
The Sixth Class	146~175 people	Additional 30%
The Seventh Class	175~200 people	Additional 35%
The Eighth Class	More than or equal to 201 people	Additional 40%

Article 3 In accordance with any of the following rules to handle the hourly pay for teachers in summer school.

I. The following system in accordance with the hourly pay of part-time teacher regulations, taking the form of 6 classes are as follows:

Classes	Number of Students	Benefit Payment Standards
The First Class	Less than or equal to 70 people	Minimum hourly pay with additional 20%
The Second Class	71~80 people	Minimum hourly pay with additional 38%
The Third Class	81~90 people	Minimum hourly pay with additional 50%
The Fourth Class	91~100 people	Minimum hourly pay with additional 62%
The Fifth Class	101~120 people	Minimum hourly pay with additional 80%
The Sixth Class	More than or equal to 121 people	Minimum hourly pay with additional 92%

For each in-person class, ninety people are the maximum number of students. However, distance learning is not restricted by this rule. The size of the summer program shall not be less than 15 students. Distance learning of compulsory subjects is required for graduation or restudying, the number of students can be less than fifteen but not less than five people. The hourly pay for distance learning is in accordance with the proportion of students.

II. The full-time professor may choose the teaching hours of a course to be counted in the next semester.

In accordance with the Ministry of Education project subsidy, the hourly pay for the instructor is based on the regulation of the project.

Article 4 The regulation shall be passed by the Administrative meeting, submitted to the President for approval, and then promulgated and implemented. Any amendments shall be processed accordingly.
